

ELIGIBLE BREEDS & REGISTRY

Open to all dogs at least 12 months of age that are individually registered with the AKC, recorded in the FSS program, dogs with PAL numbers or dogs enrolled in the AKC Canine Partners program. Females in season may not enter. A dog may enter only once per event. (An event is defined by an event number.) Dogs requiring registry in Canine Partners must be spayed or neutered and are subject to a separate registration fee of \$35.00 to the AKC.

TESTS, TITLES & TIMING

How Does a Fast CAT Work?

1. Fast CAT is a timed straight race of 100 yards.
2. Dogs run singularly.
3. The dog's time to complete the 100 yd dash is converted into mph.
4. A handicap system is applied to a dog's MPH to determine the number of points earned. The handicap system is based on the height of the dog at its withers:
 - a. 18" or greater = handicap is 1.0
 - b. 12" up to less than 18" = handicap is 1.5
 - c. Below 12" = handicap is 2.0
5. Points = MPH multiplied by the dog's handicap
6. Fast CAT suffix titles are earned at designated milestones:
 - a. BCAT = 150 points
 - b. DCAT = 500 points
 - c. FCAT = 1,000 points
 - d. FCAT# = every additional 500 points
7. Timing Devices: The time to complete the 100 yard dash is recorded to the nearest 1/100th of a second (e.g. 9.11). The club may use stop watches or break---the---beam equipment to obtain the time. If stopwatches are used, there shall be two timers positioned at the finish line. An individual at the start line shall signal with an arm drop the moment the nose of the dog crosses the start line. The timers shall start their stopwatches at the bottom of the arm drop. The timers shall stop their watches when the nose of the dog crosses the finish line. The times from the two stopwatches shall be averaged to determine the recorded time.
8. Course is permanently fenced with a snow fence run out for dog safety.

INSPECTION: A rolling roll call will be used. All dogs will be inspected for soundness measured prior to running each event. All bitches will be checked for being in Season prior to running each event.

DIRECTIONS & PARKING:

From the South: Take I- N to SR 30, go West on 30 to St 39N (Shelby exit). Turn left at Main St in Shelby, turn right at Gamble Street, this is SR 61N. Take SR 61N to Preston Road. Turn left onto Preston. Go to the 2nd stop sign. You can see the venue across the street. Follow signs for parking.

From the North: Take I-71S to SR 224 exit in Lodi. Go West on SR 224 until you get to New Haven. This is the intersection of SR 224 & SR 61. Turn left on SR 61. Go through Plymouth, take a slight right onto SR 98. Approximately 2.5mi on the right, watch for signs and parking.

From the West: Take SR 30 to Bucyrus. Take the SR 98 exit. The venue is 18 miles on your left. Watch for signs and parking.

From the East: Take SR 30 into Mansfield. Go West on 30 to St 39N (Shelby exit). Turn left at Main St in Shelby, turn right at Gamble street, this is SR 61N. Take SR 61N to Preston Rd. Turn left onto Preston. Go to the 2nd stop sign. You can see the venue across the street. Follow signs for parking.

RIBBONS & PRIZES

Qualifiers will receive a light blue flat ribbon for successful pass of test. Lorain County Kennel Club will offer a "New Title" rosette for any dog finishing any title.

GENERAL RULES

1. All dogs run at owner's own risk.
2. All entries must be one year of age or older.
3. Each entry will be examined and may be measured with a wicket at inspection. Inspection shall take place prior to any form of wrapping being applied to the dog. In the opinion of the inspection committee, any entry found to be lame, unfit, or a female in season, shall not be allowed to enter and entry fees will be refunded. The decision of the field committee is final.
4. Dogs running may wear any type collar except choker collars, a collar with prongs or an electronic training collar. A collar worn should be snug fitting with no dangling tags. Owners may have their dog wear a muzzle if they desire. NO FLEXI LEADS, PINCH/PRONG COLLARS OR ELECTRONIC COLLARS ARE ALLOWED ON EVENT GROUNDS.
5. Electric continuous loop machines will be used. Lures consist of white plastic bags.
6. The field committee reserves the right to bar known aggressive dogs from the event site.
7. There will be a \$5 fine assessed for any loose dog not taking part in the course progress (per AKC). The following actions may result in a fine and/or being excused from the event: exhibiting unsportsmanlike conduct, not picking up after one's dog, or littering in any area of the event.
8. NO ONE is allowed on the field without the express permission of the Field Chairman, except the appointed Field Committee.
9. There is NO SMOKING in the following around the Paddock area and around the Secretary's table, and nowhere on the field itself. Please be respectful of others.
10. There will be a \$10 charge for anyone not picking up after their dogs or themselves.
11. Pre-Registered Dogs must be present and inspected no later than the time that "Day of Trial Entries Close".
12. Failure to be punctual for your draw position run will result in being rescheduled to the end of the event draw
